REQUEST FOR PROPOSALS

Brown County is soliciting proposals from interested parties to provide **Jail Phone and Video Visitation Services and associated equipment** to the Board of Brown County Commissioners. Brown County is seeking Jail Telephone and Video Visitation services and equipment for 11 inmate telephones, 12 video visitation kiosks (2 public and 10 inmate), and 1 portable visitation kiosk. Mailed proposals must be sealed and will be received at 750 Mt Orab Pike, Georgetown, OH 45121 until 3:00 PM, Monday, February 11, 2019 at which time they will be opened and examined by the Brown County Sheriff and or his designee(s).

Mailed proposals must be sealed and clearly marked on the outside of the envelope, "Bid Proposal – Jail Phone and Video Visitation Services." Address proposal or hand deliver to: Brown County Sheriff, 750 Mt Orab Pike, Georgetown, OH 45121. Documents delivered to other offices and received late by the Brown County Sheriff's Office will not be considered nor will ones received by facsimile or e-mail. Submittals made in an incorrect format will not be considered.

INFORMATION PACKET

Request for Proposals for Jail Phone and Video Visitation Services

PROJECT SCOPE:

Brown County is soliciting proposals from qualified providers of Jail Phone and Video Visitation Services and associated equipment in a 110 bed jail facility located in the Brown County Sheriff's Office at 750 Mt Orab Pike, Georgetown, OH 45121.

BACKGROUND ON THIS PROJECT:

11 phones will be required for the current jail facility (10 in Inmate Day Rooms and 1 in Inmate Booking/Receiving). Any additional phones required for the existing jail facility will be at a negotiated rate.

10 visitation kiosks will be required for the jail day rooms.

2 visitation kiosks will be needed for the visitation rooms.

1 portable visitation kiosk and portable telephone unit will be required.

The County's contract with Securus Technologies expired on January 8, 2019.

MINIMUM REQUIREMENTS: The equipment and services provided will include:

Onsite video visitation

Ability to display inmate handbook

Ability to order commissary

Ability to integrate with JMS provider (Jamin) for commissary ordering

Completing grievance forms/display answers to grievances

Completing inmate requests (kites)/ display answers to kites

Secure kiosk that can survive the jail setting

Portable Video Visitation as well as portable telephone

TELEPHONE AND VIDEO SYSTEM MAINTENANCE REQUIREMENTS

The vendor shall provide 24 hour, seven days a week direct telephone assistance and repair. This shall not be an answering system or an automated phone system. Proposal should indicate the response time associated with a service call.

Vendor shall be responsible for all costs associated with the inmate telephone system and video visitation system, including purchase of equipment, installation, service, maintenance, voice network and transmission, data network, and day-to-day operation. The County shall have no responsibility for any costs associated with the system. Vendor is responsible for determining all wiring and software requirements; costs associated with the conversion of service from current inmate telephone system providers to the successful new service provider. Successful vendor shall coordinate all details of switching out services with the County's current service provider. The new telephone and video visitation systems must be working to the satisfaction of the County within 24 hours of the removal of the current systems.

All telephone and video visitation rates must comply with Federal and State guidelines.

PREFERRED APPROACH REQUIREMENTS

All proposals must contain the following information

- 1. Copy of the contract that would be offered to the County.
- 2. A complete list of all fees, commission rates, and call charges.
- 3. Availability of email and text as well as associated rates.
- 4. Time frame of implementation including go live dates.
- 5. Proposers must provide at least two (2) corrections institutions of similar inmate population where the provider is currently providing Inmate Telephone and Video Visitation Services. This list must include the facilities: name, address, contact person and length of time each contract has been in effect. This list may be used as a source of references for the vendor.
- 6. Each proposal shall describe how billing/payments will be made to Brown County and the expected terms for payments.
